**UPON THE APPLICATION** of the Applicant, the Alberta Energy Regulator (the "AER"), brought by Originating Application filed February 14, 2017 returnable at 1:00 p.m. on February 14, 2017 (the "Originating Application"); AND UPON HAVING READ the Affidavit of Cory Schieman, sworn on February 14, 2017 (the "Schieman Affidavit"); AND UPON NOTING that the Equipment Direction (as defined in the Schieman Affidavit and marked as Exhibit "S" thereto), references:

- a) section 32 of the OGCA which provides that a responsibility, obligation, or liability of a licensee, approval holder or working interest participant in respect of the operation, suspension or abandonment of a well or facility extends to associated equipment (the "Equipment") and non-licensed facilities that are used in connection with the operation, suspension or abandonment of the well or facility; and
- b) directs the Respondent, Lexin Resources Ltd. ("Lexin"), inter alia, that no Equipment be removed from the sites for which Lexin is the licensee (the "Sites") without the AER's prior approval;

AND UPON NOTING that Equipment has been removed from the Sites and also that since the Equipment Direction, Equipment has continued to be removed from the Sites, all without the approval of the AER (the "Unauthorized Activity"), as described in the Schieman Affidavit; AND UPON NOTING the AER's position that the Unauthorized Activity is:

- a) contrary to Rules 3.013, 6.040(1) and 7.001 of the Oil and Gas Conservation Rules, Alta Reg 151/1971 (the "Rules"); and
- b) subsequent to the issuance of the Suspension Order (as defined in the Schieman Affidavit), contrary to the Suspension Order, Rule 3.020 of the Rules and AER Directive 013;

**AND UPON NOTING** that pursuant to sections 19(2) and 19(3) of the *Responsible Energy Development Act* ("**REDA**"), the AER may apply to the Court for an Order prohibiting the Unauthorized Activity where a person commences, undertakes, or continues the activity for which approval is required and approval has not been obtained, or where the AER has made a direction such as the Equipment Direction regarding the Unauthorized Activity and a person has failed to comply with the direction; **AND UPON NOTING** that section 103(2) of the *Oil and Gas Conservation Act*, RSA 2000, c O-6 ("OGCA") provides the AER with a statutory priority lien as more particularly described therein (the "Lien"); AND UPON NOTING the Personal Property Registry Search Results Report conducted in respect of Lexin, describing parties whom, as at February 8, 2017, claim interests in some or all of the Equipment by virtue of security interests and writs of enforcement (the "PPR Claimants"), a copy of which is marked as **Exhibit "W"** to the Schieman Affidavit; AND UPON NOTING the list of all of Lexin's WIPs known to the AER and their addresses (the "Known WIPs") which is marked as **Exhibit "X"** to the Schieman Affidavit; **AND UPON NOTING** the Affidavits of Service indicating that service of the Originating Application and the Schieman Affidavit was effected upon Lexin by personal service and upon counsel for Lexin and the Directors (as defined in the Schieman Affidavit), Groia & Company Professional Corporation, by email, on the morning of February 14, 2017; **AND UPON NOTING AND UPON HEARING** the submissions of counsel for the Applicant, the AER, [and counsel for Lexin]; Whe appeared with Wife mattice and provide the fill has a provide the fill with the fi

IT IS HEREBY ORDERED AND DECLARED THAT:

1. All parties entitled to notice of the Originating Application have been served with notice of the same; the time for service of the Originating Application is hereby abridged such that service effected on the parties served with notice of the Originating Application shall be good and sufficient notice of the Originating Application, pursuant to Rules 11.27 and 13.5 of the Alberta Rules of Court; and it is appropriate in the circumstances that the Originating Application proceed at the appointed time.

2. Pursuant to section 19(2) of REDA, all persons, including but not limited to Lexin and its directors, agents and employees, as well as the Known WIPs, the PPR Claimants, and anyone claiming liens, charges, set-off rights, mortgages, and other security interests against Lexin, or affecting the Sites, are hereby ordered to refrain from and are hereby prohibited from engaging in the Unauthorized Activity except:

- (a) with the written prior approval of the AER; or
- (b) if otherwise ordered by this Court on an application to this Court brought with not less than 7 days' notice to the AER.
