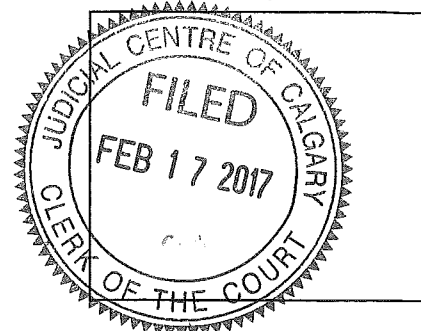

NAME OF JUDGE WHO MADE THIS ORDER: Mr. Justice W.A. Tilleman

UPON HEARING submissions from counsel for the Applicant (the "AER"); **AND UPON HEARING** submission from counsel for the Respondents; **AND UPON NOTING** the interim order granted by the Honourable Justice W. A. Tilleman on February 14, 2017, ("Interim Order") directing the parties to return on February 17, 2017 to determine if there should be an extension of the

Interim Order; **AND UPON** reading the affidavit Cory Schieman sworn February 14, 2017 and the affidavit of Tatsiana Okun sworn February 16, 2017 **AND UPON** hearing from counsel for Indian Oil and Gas Canada in support of the AER's application;

IT IS HEREBY ORDERED AND DECLARED THAT:

1. The Interim Order shall extend and remain in place until the disposition of the AER's Originating Application on its merits scheduled to be heard at 9:00am on March 3, 2017 or such other date as the Court may Order.
2. The schedule relating to the March 3, 2017 hearing on this matter is as follows:
 - (a) The AER and any other parties interested in making submissions in support of the AER's Originating Application shall file and serve any further evidence by 12:00pm MST on Wednesday, February 22, 2017;
 - (b) The Respondent shall file and serve any further evidence by 4:00pm MST on Thursday, February 23, 2017;
 - (c) Any cross examination of Cory Schieman on his Affidavits filed in this matter shall occur no later than Friday, February 24, 2017;
 - (d) Any cross examination of any other parties on their Affidavit evidence in this matter shall occur no later than Monday February 27, 2017;
 - (e) Any Briefs of Argument shall be filed and served by the end of the business day on Wednesday March 1, 2017.
3. All PPR Claimants (as defined in the Interim Order) must be served with a copy of this Order at the addresses outlined in Schedule A to the Interim Order; and
4. All Known WIPs (as defined in the Interim Order) must be served with a copy of this Order at the addresses outlined in Schedule B to the Interim Order
